2. Chair's Opening

The chair welcomed all to the meeting. He congratulated the successful election candidates and Cllr Clelland on his appointment as chair of the Area Committee

5. Jubilee Celebrations

Billy Archibald outlined the arrangements for the celebrations relating to Saline Golf Club's centenary and Queen's Jubilee. It had been agreed that these would be held on Saturday 2nd June and run for the whole day with a wide variety of events and attractions for all. This has involved considerable fund raising and John Crane, seconded by Donald Murdoch, proposed a donation from the community council. A sum of £100 was agreed.

It was noted that Saline Historical society is holding a cream tea and open day at the museum on Jubilee Day and it was hoped that this would be well patronised It was also noted that Saline Golf Club and Steelend Club wish to attract new members. D Quinney indicated that he had membership forms for anyone interested

6. Councillors' Report

Cllr Clelland reported that the new Administration had changed Fife Council's set up that delegated more responsibilities to Areas. As noted by John Crane, he was now chair of the local Area Committee

Cllr indicated that the 4 local councillors had discussed attendance at community councils and that he, Cllr Callaghan and Cllr Ferguson had supported a continuation of the previous arrangement of each councilor being responsible for attendance at 3-4 community councils on the basis that residents could still contact any councillor. Cllr Clelland will be attending Saline and Steelend, Oakley and Comrie and Blairhall Community Councils. However, Cllr Stewart has indicated that she will be attending all community councils.

7. Treasurer's Report

Marie Crane advised that the current balance is £197.49 less the £100 to be paid to Saline Golf Club. The grant from Fife Council (£647.40) has still to be received. Funds for Bonfire Night have been ring fenced and a new fireworks catalogue has been received. To achieve maximum discount, it is necessary to order the fireworks

soon. This was agreed and it was remitted to John Crane and Mark Johnstone to organize this. It was also agreed that the Bonfire Night should be 3rd November

8. Planning

Joan Featherstone reported on current planning applications that were uncontroversial. She advised on discussions with Development Services re the Saline Hotel site. Development Services are likely to recommend approval of the application as it stands as access from the rear is not feasible due to ownership complications.

Development Services have declined the community council's request for a meeting regarding The Glebe planning application on the grounds that this would be unproductive. Members were concerned at this response as the objective of the meeting was to promote a solution that minimised conflict. Accordingly, John Crane will write again to Development Services to confirm the community council's position and seek the proposed meeting.

Joan tendered her resignation as Planning Representative and this was reluctantly accepted by the chair

9. Secretary's Report
